CORRIGENDUM

This Ministry's letter No. B/27654/AG/PS 3(a)/306-S/ D(Pay/Services) dated the 11th June, 1984, regarding Ex-Gratia payments in respect of the casualties of Operations "BLUE STAR" and "WOOD ROSE" is amended as under :-

(a) The following may be added at the end of existing paragraphs 2 :-

"However, the payment of ex-gratia lump-sum grant of Rs. 75,000/- in cases of invalidment out of service will not be made from the Army Headquarters' Welfare Fund but will be made by the Controller of Defence Accounts (Pensions), Allahabad."

(b) The following may be added as paragraph 3 and the existing paragraphs 3 and 4 may be re-numbered as paragraphs 4 and 5 respectively :-

"3. The mode of payment of ex-gratia award to the next-of-kin of those who died during the above operations will be as under :-

(i) In the case of Officers ..... Cash

(ii) In the case of JCOs and ORs

Fixed Deposit in any Nationalised Bank for a period of 5 years with the option to draw interest thereon every month or to receive the payment of the principal amount together with interest accrued thereon on the maturity of the fixed deposit."



Sir,

I am directed to refer to this Ministry's letter No. B/27 AG/PS 3(a)/306-S/D(Pay/Services) dated 11th June, 1984 read with letter No. B/27654/AG/PS3(a)/346-I/S/D(Pay/Services), dated 30.6.84 on the above subject, and convey the sanction of the President to the reimbursement of Rs. 94,00,000/- (Rupees Ninety Four Laks) to the AG's Welfare Fund, Adjutant General's Branch, Army Headquarters, New Delhi on account of expenditure incurred by them in connection with ex-gratia payment made to the families of officers and other ranks (as per lists A&B annexed) who were killed in OP Blue Star, OP Wood Rose and while disarming Army deserters in other parts of India, as a corollary to these operations.

Subject:- Concession of ex gratia lumpsum grant -  
Operation BLUE STAR and Operation WOOD ROSE.

Sir,

I am directed to convey the sanction of the President to the payment of ex gratia lumpsum grant as under to the troops deployed in Operation BLUE STAR and Operation WOOD ROSE, in addition to the concessions sanctioned in this Ministry's letter No.B/27654/AG/PS3(a)/292-S/D(Pay/Services), dated 4.6.1984, as amended:-

- (a) In the case of death - Rs. 1,00,000/- to the family.
- (b) In case of invalidment - Rs. 75,000/- out of the Service

2. To hasten the ex gratia payment, as sanctioned above it may be made from the Army Welfare Fund or any other Fund under the control of the Army Headquarters. All expenditures incurred on this account by such Funds will be reimbursed by the Government by making grants to them.

3.4 This takes effect from 1.6.1984 and will be in force till the above Operations are completed or 31.12.1984, whichever is earlier.
