Subject :- REVISION OF RATES OF PENSION CONTRIBUTIONS PAYABLE
BY DEFENCE SERVICES PERSONNEL DURING FOREIGN SERVICE.

Sir,

In supersession of all existing orders on the subject I am directed to say that the President is pleased to revise the rates of Pension Contributions in respect of Defence Service Personnel during Foreign Services as laid down in Appendix to this letter. These revised rates shall be calculated on the maximum of the pay scale and Dearness Pay/ Interim Relief admissible on the maximum of the pay scale of the post held by the person in the substantive/officiating grade as the case may be at the time of proceeding on foreign service.

2. The Pension contribution may be paid annually within fifteen days from the end of each financial year or at the end of the foreign service, if the deputation on foreign service expires before the end of a financial year, and if the payment is not made within the said period, interest must be paid to Government on the unpaid contribution, unless it is specifically remitted by the President, at the rate of two paise per day per Rs. 100/- from the date of expiry of the period aforesaid upto the date on which the contribution is finally paid. The interest shall be paid by the Government servant or the foreign employer depending on whether the contribution is paid by the former or the latter.
3. The revised rates will take effect from 1st January, 1986.
4. This issues with the concurrence of the Finance Division of this Ministry vide their u.o.No. 2940-Pen of 1986.
