Sir,

I am directed to refer to this Ministry's letter No. PN/1280/506/CC/C/D(Pen/Sers), dated 5th September, 1997 regarding implementation of Hon'ble Supreme Court judgement dated 28th November, 1996 in CA No.1110/92 and to clarify that full 4 years training period as Artificer Apprentice from the date of enrolment will count as qualifying service for pension and gratuity, irrespective of whether a portion of the training period has been rendered prior to the age of 17 years.

2. Formal amendment to Regulation 79(ii) of Pension Regulations(Navy) 1964, will be issued in due course.

3. This issues with the concurrence of Finance Division of this Ministry vide UD No.372/Addl,FA(P)/98, dated 13th February, 1998.
