Sub:- Rates of Service Pension of Naik, Corporal
AND Leading Seaman retiring on or after
01/01/1992.

Sir,

In partial modification of this Ministry's letter No.1(5)-87/D(Pension/Services), dated 30.10.87 as amended vide para 15.1 of Ministry of Defence's letter No. 1(2)/92/D(Pension/Services) dated 16.03.92 and letter No. 1(1)/92/D(Pension/Services) dated 02.04.92, I am directed to convey the sanction of the President for the grant of service pension to Naik, Corporal and Leading Seaman of the Three Services who have been discharged on or after 1.1.86 and rendered actual qualifying service of 15 years or more but less than 17 years at the same rates as admissible for those with actual qualifying service of 17 years. As regards gratuity, it will be calculated on the basis of actual qualifying service plus usual weightage as hitherto. The provisions made in para 5 & 6 of this Ministry's letter dated 30.10.87 ^{or} ibid will be accordingly deemed as amended. The revised rates of Service Pension are given in Annexure 'A' of this letter. The arrears of pension and Dearness Relief thereon will be payable from 1.1.92.

2. The revision of Service Pension of the Armed Forces pensioners who retired holding the above mentioned ranks on or after 1.1.86 will be done by the pension sanctioning Authorities, namely Chief CDA(P) Allahabad, CDA(Navy), Mumbai and CDA(AF), New Delhi by issue of Corrigendum Pension Payment Order on receipt of an application from the pensioners as per Annexure-B to this Letter.

3. In case a pensioner has died on or after 1.1.92. the arrears of pension will be authorised to his Legal heir.

4. This issues with the concurrence of the Finance Division of this Ministry vide their UO No. 2025/Pen/98 dated 15.09.98.
