Sir, I am directed to invite a reference to the letters : 1 mentioned below on the above subject and to say that in view of the Ministry of Defence letter No. 20(1)/98/D (Pay/Ser) dated 22.9.98 providing for grant of ex-gratia payment of Rs. 5.00 lakhs each to the families of the Armed Forces personnel who die in harness during the performance of bonafide official duties/due to accidents(including accidents to the service aircraft) in the course of performance of official duties, the said letters dated 26.6.78, 21.3.79, 9.2.83 and 16.5.89, stand superseded with effect from 1.8.97, is. the date from which the provisions of the Mon letter No. 20(1) 798/D(Pay/Ser) dated 22.50

provisions of the MOD letter No. 20(1)/98/D(Pay/Ser) dated 22.9.98 came into force:-

- 3. Ex-gratia amount which have already been paid to the parents as per instructions mentioned in the letters referred to in para 1(1) and (ii) above, between 1.8.97 to 22.9.98 will not be recovered. The balance amount, if any, will be paid to the wife/children of the deceased.
