SUBJECT:-RESTORATION OF 43% AND 45% COMMUTED
PORTION OF PENSION AFTER 15 YEARS FROM THE
DATE OF COMMUTATION IN RESPECT OF ARMED
FORCES ABSORBEES WHO HAD DRAWN LUMP SUM
AMOUNT ON THAT ABSORPTION IN A
PSU/AUTONOMOUS BODY -- IMPLEMENTATION OF THE
SUPREME COURT JUDGEMENT

Consequent upon issue of MOD ID No. 211/A/D(Pen/Sers) dated 23.10.96, ID No. 8(1)/96/D(Pen/Sers) dated 15.12.1998 and ID No. 8(1)/96/D(Pen/Sers) dated 24.6.99, the provision contained in Ministry of Personnel, Public Grievances and Pension, Deptt of P&PW OM NO. 4/3/86-P&PW(D) dated 30.09.96, OM No. 4/3/86-P&PW(D) dated 13.01.1998 OM No. 4/59/97-P&PW(D) dated 14.7.1998 and OM No. 4/56/98-P&PW(D) dated 28.12.1998 for Defence Civilians will apply Mutatis Mutandis to Armed Forces Absorbees.

In view of the above provision of Deptt of P&PW OM dated 30.9.96 and above OMs are to be modified to the extent, they suit to the Defence absorbees in regard of the procedure to be followed by them. Accordingly, para 5 of OM No. 4/3/96-P&PW dated 30.9.96 is modified to that extent and the detailed procedure to be followed by Armed Forces absorbees is given below:-

The PSUs/Autonomous body's absorbees belonging to Commissioned Officer of Army, Navy and Air Force will apply for restoration of their pension on the prescribed application form attached as Annexure 'A' to this letter alongwith two passport size recent photographs and two slips containing three specimen signature on each to DG Org3&9 through Dir AG PS-4 Army Hqrs, DPA Naval Hqrs and Dte of PP&R Air Hqrs.

respectively. Whereas PBOR absorbees of Army, Navy and Air Force will furnish their application to concerned Record Officer/Bureau of Sailors and AFRO respectively. These authorities will verify the correctness of the entries made in the application form and endorse the same under their seal certifying that the particulars given therein are correct and in turn will forward the same to Pay Controller concerned for the fixation of notional Pay/Minimum Pay of the rank introduced 1.1.96 and onward submission to respective pension Authority.

Applications of the officers and PBOR of all three services who were absorbed prior to 1.11.85 will be forwarded to CCDA(P), Allahabad and in cases of Naval/Air Forces Officers who were absorbed on or after 1.11.85 such application will be forwarded to the respective PSAs by the concerned Directorate/Branch and Record Offices/Bureau of Sailors and Air Force Record Offices.

On receipt of the application the PSAs will verify and link the case with original records held in their office and if found correct will restore 43% and 45% of pension as the case may be through a PPO and send the same to the PDA Banker given by the applicant in his application form together with a copy of photograph and slips containing specimen signature for further necessary action under intimation to applicant to approach his PDA for receiving payment. However, in case of PBOR, PPOs will rout through the ROs/Bureau of Sailors and AFRO.

Family Pension where required to be notified will be governed under the existing Government Orders.
