## SANCTION OF 50% CENTRAL SHARE TOWARDS COST OF CONSTRUCTION OF Sainik REST HOUSE AT SOLAN IN HIMACHAL PRADESH

Sir,

I am directed to convey the sanction of the President towards construction of Sainik Rest House at Solan as proposed by Director, Sainik Welfare, Himachal Pradesh with financial effect of Rs. 1,57,66,200 (Rupees One crore fifty-seven lakh sixty-six thousand two hundred only) on account of 50% cost of construction of Sainik Rest House, Solan as Central share to Himachal Pradesh out of DSE Budget. Payment of Rs. 1,57,66,200/-(On 50% sharing basis will be released in two instalments. First instalment of 50% construction cost for Rs. 78,83,100/- shall be released initially subject to availability of funds.
