APPROVED MINUTES OF THE 31ST MEETING OF KENDRIYA SAINIK BOARD HELD ON 11 APR 2023 AT VIGYAN BHAVAN, NEW DELHI

- The 31st Meeting of Kendriya Sainik Board (KSB) was held on 11 Apr 2023 at Vigyan Bhavan, New Delhi under the Chairmanship of Shri Rajnath Singh, Hon'ble Raksha Mantri. The list of participants is enclosed at Annexure.
- Secretary, KSB in his inaugural remarks, welcomed the Hon'ble Raksha Mantri Sh. Rajnath Singh, Chairman KSB, members of KSB and special guests to the 31st Meeting of KSB on behalf of Department of Ex-Servicemen Welfare.
- 3. Joint Secretary, ESW thanked the presence of the Chairman, all the members of KSB and other dignitaries attending the meeting. He highlighted the contribution of Armed Forces personnel in defending the country and also playing a vital role during natural calamities and other contingencies. He expressed that it is our prime responsibility to address problems of ESM, Veer Naris and their dependents empathetically.
- 4. Thereafter, Hon'ble Raksha Mantri in his remarks thanked and welcomed the public representatives, Chief of Defence Staff, Chief of Naval Staff, Chief of Army Staff, Secretary ESW and senior officials of central and state govts for their presence. He mentioned that although we meet frequently and discuss about the issues of ESM welfare and conduct various activities, but formally organising this KSB meeting shows our special concern towards the welfare and wellbeing of the ESM and their families and such endeavours create a sense of security amongst our brave soldiers who defend their country and their families for their future.
- 5. He was appreciative of the fact although ESM have formally exited from service, their patriotism and commitment to the nation never diminishes. They are an asset and the Nation is proud of them. It is thus a national responsibility to look after the resettlement of these heroes and their families so that they can live a dignified life. He said that the government is committed towards the cause.
- 6. He emphasised the fact that many professionals such as bureaucrats, doctors, engineers, teachers, etc serve the nation. But a dedicated department is functioning only under Ministry of Defence for the veterans. This is a proof of the national priority, concern and responsibility shown by the Govt towards the veterans.
- 7. Moving on to the Agenda for the meeting, the Hon'ble RM requested all members to provide constructive suggestions as each point was important for the welfare of the soldiers and veterans.
- 8. Each of the Agenda item were explained in the form of a presentation by the Secretary KSB and thereafter deliberated upon by the Secy ESW and members. Hon'ble Ministers/ Members of Parliament from Andhra Pradesh, Assam, Delhi, Haryana, Himachal Pradesh, Madhya Pradesh, Punjab, Rajasthan, Sikkim and Uttar Pradesh gave their views on various issues and also highlighted the work and the benefits being given in their respective States. Other members/ invitees including the CDS, Service Chiefs and the Secretaries-in-Charge of ESM welfare of State govts also gave their view points and valuable inputs.

Discussion/ Action Points on Agenda Items

- Based on the discussions on each Agenda item, the action-points which have emerged are mentioned in succeeding paragraphs.
- Item 1 Armed Forces Veterans Day Celebrations.
 - (a) <u>Discussions</u>. The Armed Forces Veterans Day is celebrated on 14 Jan every year. It was proposed to enhance the scope of the Veterans Day Celebrations. The details of recent Veterans Day celebrations on 14 Jan 2023 were highlighted, wherein Union Ministers had also attended the events at nine locations across the country and activities such as felicitation of Veterans/ Veer Naris, awareness campaigns, special announcements in airports/ flights was undertaken. A need to take this activity to grassroots level to reach the remotest ESM was agreed to by all. The following points were brought out by various Members:-
 - (i) Gen Anil Chauhan, PVSM, UYSM, AVSM, SM, VSM, Chief of Defence Staff. The quality of next generation of soldiers joining the Armed Forces, is directly dependent on how we look after our Veterans today. More than the monetary benefits, measures to recognise the services of the veterans must be looked into.
 - (ii) Sh. Suresh Kumar Khanna, Minister In-charge, UP. The scope of Armed Forces Veterans Day needs to be expaned. In UP, all 75 districts of the state will celebrate this programme with full honour.
 - (iii) Sh. Narottam Mishra, Minister In-charge, MP. Madhya Pradesh has implemented several measure for the Veterans, Veer Naris & their dependents like:-
 - (aa) Ex-Gratia Grant of Rs. One Crores to the Veer Nari and job in State Govt for one member of the family.
 - (ab) Last rites of the soldiers who make the supreme sacrifice is is personally attended by CM himself or by Minister Incharge, in his absence.
 - (ac) Award of Rs. 10,000/- pm to the parents of the girls on joining Army.
 - (ad) Construction of Sainik Rest Houses in 17 Districts of the State.
 - (ae) 124 veterans of WW-II in the state are awarded with Monthly Pension of Rs. 8,000/-.
 - (af) A "Shaurya Samarak" has been built in Bhopal.
 - (iv) Sh. Manvendra Singh Jasol, Minister In-charge, Rajasthan Veterans are role models who must engage with the future generations of the country, especially in border areas. Veterans should be invited to the Schools, especially in villages, as guest faculty to share their wisdom and experience with the children.

- (v) Sh. Ranjit Kumar Das, Minister In-charge, Assam. The proposal to enhance the scope of the Armed Forces Veterans Day is a welcome step. Celebrations at district level will ensure that maximum Veterans can be felicitated and recognised.
- (b) <u>Decision</u>. A whole of Govt approach is necessary to have a meaningful celebration of the event at grassroots level. The State Govt through RSBs to plan associated events in coordination with nearest Defence establishments.
- (c) Action By. DMA, DESW, Service HQs for coordination/nomination of Defence establishments, State/ UTs through RSBs.

Item 2 – Enhancing Pride Amongst ESM Community.

- (a) <u>Discussions</u>. An ESM cherishes the honour and respect earned in the society. Towards this it was proposed to institute measures which would instill pride amongst ESM Community. This will also encourage them to come forward during contingencies as ESM possess certain skills and positive attitude which is an asset and should be harnessed by State Govts. Besides this, an ESM primarily looks at timely resolution of local administrative issues. Measures already in vogue in certain States were brought to notice by members from States. The following points were brought out by various dignitaries:-
 - (i) Sh. Suresh Khanna, Minister In-charge, UP. Uttar Pradesh Government is committed towards the Welfare and resettlement of our Veterans and Veer Naris. We have instituted several measures in this area like:-
 - (aa) 5% reservation in Gp B, C and D posts, 8% reservation in Govt Ration Shops and No stamp duty for purchase of land upto Rs. 20 Lakh and Rebate in House Tax.
 - (ab) The state Govt has provided financial assistance of Rs. 13 lakh (Rs. 1.5 lakh per veteran) for the 9 disabled Veterans of the State in PRC Mohali and Kirkee. Last year the Hon'ble Governor also donated Rs. 10 lakh each to both these centres.
 - (ac) The State has instituted a concept of 'Sainik Bandhu' wherein a nodal officer for Veterans has been nominated in each district. Monthly meeting is organised to address all the concerns of ESM by the District Officials including Police and Revenue Officials.
 - (ii) Gen Manoj Pande, PVSM, AVSM, VSM, ADC, Chief of the Army Staff. Measures like visible symbols such as Veterans badge or vehicle stickers may be incorporated for enhancing pride amongst ESM Community.

- (iii) Gen Anil Chauhan, PVSM, UYSM, AVSM, SM, VSM, Chief of Defence Staff & Secretary DMA. Instituting non-financial measures/ incentives are necessary to ensure that future generations look forward to taking up the profession of Arms. On the occasion of Veterans Day (14th Jan) and other prominent days, Armed Forces Veterans and Serving Officers may be made of part of the celebration in various Schools so that the younger generation may be motivated to join Armed Forces and become a good soldier or citizen.
- (iv) Lt. Gen (Dr) DP Vats (Retd), MP (Rajya Sabha). All States may institute a concept wherein Public representatives and Civil Administration visits and interacts with the Veer Naris and family of the fallen soldiers. A brief ceremony may also be organized in various Memorials to pay tribute to our heroes. States of Punjab, Haryana, Uttarakhand and Himachal Pradesh are already putting this into practise, wherein the MP/MLA or DC pay tribute to the fallen soldiers.
- (b) <u>Decision</u>. Innovative measures are required to ensure that ESM are given due respect in the society. State and UT Govts should accordingly issue orders to formalise innovative non-financial incentives/ measures to enhance pride amongst ESM. Some of the suggested measures are: -
 - (i) Facilitate interaction with local administration officials through nomination of a nodal officer in the district.
 - (ii) Regular meetings at district level with Govt representatives especially of land, revenue and law and order departments to resolve issues of ESM.
 - (iii) Outreach programmes could be conducted through video conferencing for veterans in remote areas.
 - (iv) Felicitation of Gallantry Award winners during important national events
 - (v) Naming of Roads, buildings, etc on gallantry award winners.
 - (vi) Sensitisation of all Govt staff to deal respectfully towards veterans and their families.
 - (vii) Support the setting up of a 'Smarak'/ War memorial for service personnel killed in action.
 - (viii) The best practices being followed by certain States should be shared with other States/UTs to enable other States to also emulate the same.
- (c) <u>Action By</u>. State/ UT Govts

- 12. <u>Item 3 Vacant Posts In Offices Of Rajya Sainik Boards (RSBs) And Zila Sainik Boards (ZSBs).</u>
 - (a) <u>Discussions</u>. The issue of large number of vacancies in RSBs/ZSBs (25% in officers and 35% in staff) was brought out. It was mentioned that appointment of officers and staff in ZSBs is most essential as their non-availability adversely affects the services provided at ZSBs. The primary reasons for non-filling up of posts was attributable to non-availability of approvals from State/UT Govts, variation in pay and allowances and variation in age criteria for appointments from the MoD Guidelines of 2013. It was also apprised to the members that majority share of establishment cost of RSB/ZSBs (75% for special category states and 60% for remaining states) is paid by central Govt. Thus, the States should fill the posts on priority. The issue has also been highlighted by the Parliamentary Standing Committee on Defence during its review of functioning of ZSBs. Sh. Suresh Khanna, Minister In-charge, UP, informed that the state has proactively filled almost all the vacancies in its 75 ZSBs
 - (b) <u>Decision</u>. All States/ UTs should fill the vacant posts in RSBs and ZSBs from among ESM on priority to ensure their smooth functioning.
 - (c) Action By. State/ UT Govts.

13. Item 4 - Integrated Sainik Complex (ISC).

- (a) <u>Discussions</u>. ESM community is being provided the facilities of ECHS Polyclinics, CSD Canteen and Sainik Rest Houses (SRHs) with/ without RSB/ZSB office, each of which have their own independent procedures for setting up/ maintenance. The SRH component as of now is being provided 50% of cost of construction by Central Govt. It was proposed to have these facilities co-located in an integrated complex for the convenience of ESM. States of Punjab, Chhattisgarh, Rajasthan and Telangana had already commenced operating ISCs. While there was broad agreement on the need for an integrated facility, it emerged that while the existing facilities could not be changed, any new ZSB/SRH/ECHS polyclinic/CSD Canteen being set up should be in an integrated format. The following points were brought out by various dignitaries:-
 - (i) <u>Dr. Gaurav Uppal, Representative, Telangana</u>. Telangana State has already constructed 03 ISC and 01 is under construction. Amount of Rs. 3.75 crore as Central Share for construction is awaited.
 - (ii) Sh. Kailash Gehlot, Minister In-charge, Delhi: The concept of ISC is highly appreciated. Delhi has typical problem of land availability due to massive urbanization and seeks assistance for provision of land for construction of ISC.
 - (iii) Sh. Ashish Butail, Minister In-charge, HP. In view of geographical condition of the State, it is always a challenge to identify suitable location for construction of such facilities

- (iv) Lt. Gen (Dr) DP Vats (Retd), MP (Rajya Sabha). ISC will be very useful in providing various facilities to the Veterans, especially in non-military stations. Various Military Camping Grounds in Non Military areas may be considered for this project. It will also obviate the problems related to encroachment of these Military Camping Grounds
- (b) <u>Decision</u>. Integrated Sainik Complex is the way ahead to optimise the land resources and also to provide convenience to ESM community. Towards this the following should be implemented: -
 - (i) All State/UT Govts should consider the Integrated Sainik Complex model for any new ZSB and SRH projects/ renovations. KSB/ DESW will contribute 50% of cost for such project as done at present for SRH.
 - (ii) DESW (KSB Sectt/ ECHS) and IHQ MoD(Army)/ QMG Branch (DDG Canteen Services) are to work out modalities and formulate policy for implementation of concept of Integrated Sainik Complex.
- (c) Action By. State/UT Govts, DESW (KSB Sectt, ECHS), QMG Branch/DDG Canteen Services

Item 5 - Leveraging Data of SPARSH.

- (a) <u>Discussions</u>. SPARSH is the largest pension platform in Government and the pensioner base is expanding every year. SPARSH 2.0 will provide a Golden data set' of verified clean, validated & integrated data set of pensioners to the citizen-facing organizations like RSB/ZSB. It was proposed to leverage this data to provide various services to ESM. Some members brought out the challenges currently faced by ESM in their data verification/ modification through Record Offices as there is variance in procedures being followed. It was also brought out that while ESM are able to address SPARSH related issues through local Military Stations, they face lot of difficulty in non-military stations. It was apprised to members that providing SPARSH access facility to ZSBs through Common Service Centres (CSCs) would enhance the reach for early resolution of ESM issues. Also the long term goal will be to have a single Card for all ESM benefits. The following points were brought out by various members:-
 - (i) <u>Shri Subhash Chander, Representative, Goa</u>. Creation of a master data of the ESM is a welcome step. Such data must also be shared with the States so that targeted intervention of various welfare schemes at State level may be undertaken.
 - (ii) <u>Sub Dilbag Singh Malik (Retd), Veteran Member</u>. Veterans and Widows are facing major challenges related to SPARSH, especially in non-military stations. Additional efforts are needed to resolve the issues related to SPARSH, especially in non-military stations.
 - (iii) Rear Admiral Satish Bajaj, AVSM, VSM (Retd), Veteran Member. SPARSH should be more responsive. Grievances of Veterans should be given prompt reply and timely resolution.

- (b) <u>Decision</u>. SPARSH data is to be utilised for not only pension related issues but also as a central database of ESM with the Record offices, ECHS, CSD Canteen and RSBs/ZSBs, etc. Towards this the following should be progressed: -
 - (i) State/UT Govts to liaise with the Common Service Centre network to set up SPARSH access facility in ZSBs. IT Infrastructure and manpower to be worked out by RSBs/ZSBs. CGDA to provide necessary training to ZSB staff and support for integration with CSCs.
 - (ii) Development of SPARSH 2.0 by CGDA to enable availability of Golden data set of all ESM.
 - (iii) CGDA to plan site visits/ survey by M/s TCS to the nominated ZSBs/RSBs to assess ZSBs' requirements for SPARSH 2.0.
 - (iv) ECHS, CSD Canteen and RSB/ZSBs to be onboarded on the SPARSH system so as to provide access to relevant SPARSH data.
 - (v) Progress towards a 'One Nation One Card' for ESM for availing benefits of Central/State Schemes, ECHS and CSD.
- (c) Action By. CGDA, DESW (KSB Sectt, ECHS), QMG Branch/ DDG Canteen Services, State/UT Govts.

15. Item 6 - Enhancement of Grants Under Armed Forces Flag Day Fund.

- (a) <u>Discussions</u>. A number of requests have been received for enhancement of grants provided through AFFDF. The members were apprised that grants of about Rs 800 crores have been given to about 3.16 lakh individual beneficiaries and institutions in the last three years and every year there has been 100% utilisation of allotted funds. The grants for Penury, Marriage, Disabled Child, Orphans and Mobility Equipment have been enhanced in the last six years. It was mentioned that the grants for Vocational Training, Medical grant and Serious Diseases could be enhanced for benefit of widows and non-pensioner ESM. There was a agreement amongst the members for enhancement of grants.
 - (i) Vocational training grants for widows may be increased from Rs 20,000/- to Rs 50,000/-.
 - (ii) Medical grants for non-pensioners and non-ECHS may be increased to Rs 50,000/-.
 - (iii) Serious Disease grant may be increased up to Rs 1.5 lakh.
- (b) <u>Decision</u>. AIP is accorded for enhancement of Vocational Training Grant, Medical Grant and Serious Diseases Grant. DESW/KSB Sectt is to process the case on file for approval of Competent Authority.
- (c) Action By. DESW/ KSB Sectt.

16. <u>Item 7 - Uniformity of Welfare Benefits, Grants for Gallantry/ Distinguished Service Awards and Removal Of Domicile Criteria</u>

- (a) <u>Discussions</u>. There is wide variance in the amount of grants provided by different States/UTs, especially in the Ex-gratia amounts and the Cash benefits for Gallantry/Distinguished Service Awards. Though it was acknowledged that each State provides the grant as per respective financial capacity. Further discussions were also held on the domicile criteria restrictions in some States wherein it was brought out that such restrictions prevented an ESM/ his family members from availing benefits of the State despite residing in the State. The following points were brought out by various members:-
 - (i) Lt. Gen (Dr) DP Vats (Retd), MP (Rajya Sabha). The variation in Ex-gratia grants and the Cash benefits for Gallantry/Distinguished Service Awards need to be addressed earnestly by the States and UTs.
 - (ii) Sh. Suresh Khanna, Minister Incharge, UP. Domicile requirement is not mandatory in UP State. Only address verification is required for State benefits.

(b) Decision.

- States/UTs may revisit the rates and consider enhancing them.
- (ii) States/UTs should consider a suitable waiver for all service personnel (serving and retried) from domicile criteria restrictions especially for availing job reservations in States and admissions for their wards in educational institutions.
- (iii) A suitable DO letter is to be sent from Hon'ble RM to all CMs/LGs as an advisory to consider relaxation wrt domicile status.
- (c) <u>Action By</u>. State Govts/ UTs, DESW/KSB Sectt

17. ITEM 8 - ESM Reservation in State Govt Jobs

- (a) <u>Discussions</u>. Most States/UTs provide reservation for ESM in State Govt jobs. Some are providing reservation only in Group C & D jobs, whilst a few have extended reservation to all Groups. The members from states mentioned the respective schemes which are already in force. Some have sought clarity on the issue as the Gp D posts were abolished after VII CPC and some GP C posts were upgraded to Gp B. It was brought out by members from UTs that DoPT needs to clarify on this issue. The issue of under utilisation of the reservations was also brought out and the need for having an ESM reservation monitoring mechanism in each State was suggested. The following points were brought out by various dignitaries:-
 - (i) <u>Lt. Gen (Dr) DP Vats (Retd), MP (Rajva Sabha).</u> There is a requirement to conduct detailed study into the availability of ESM Reservation and its utilisation pattern to formulate effective policies for its implementation.

- (ii) Lt Gen C Bansi Ponnappa, PVSM, AVSM, VSM, Adjutant General. Due to horizontal reservation all the available vacancies for ESM do not get filled up. Four States have no Reservation for ESM. These aspects need to be looked into.
- (iii) Shri Chaitanya Prasad, IAS, Representative of Bihar. Govt of Bihar has introduced a alternate reservation policy on special vacancy instead of general reservation. There is a special Auxiliary Police Battalion with 3500 posts reserved for Veterans.
- (iv) Mis Padma Jaiswal, Representative of Puducherry. Govt of Puducherry provides ESM reservation in Gp D (20%) and Gp C (10%). However, Post 7th CPC, Gp D Posts have either been abolished or upgraded to Gp C Posts which is causing problems in providing full vacancies to the ESM. In this connection Govt of Puducherry has already written letter to DoPT.

(b) <u>Decision</u>.

- (i) All states are requested to provide reservation for ESM in State Govt/ institutions/ PSUs and also consider offering of their Milk Federation run milk booths/ parlour as a resettlement option.
- (ii) States/UTs should set up a monitoring mechanism/ dedicated officers to monitor the utilisation of ESM reservations.
- (iii) States should formulate their Master Rosters for ESM Reservation to smoothen the process for identification & filling up of ESM vacancies in various States/UTs, Ministry/ Deptt.
- (iv) States may consider award of Graduation Certificates to ESM through State Universities, as being done by Andhra University & Punjab University
- (c) Action By. State Govts/ UTs, DESW/DGR

18. <u>Item 9 - Establishing ESM Corporation in Respective States</u>

- (a) <u>Discussions</u>. It was brought out that many States are having ESM corporations which provide employment to ESM. Members expressed that despite being State ESM Corporations, they have to participate in Govt tenders though normal bidding which is disadvantageous. It was proposed to issue directives from Central Govt for enabling use of only State Corporations. It was suggested that at least for Security of sensitive establishments/ installations, such rules could be set. The issue of exemption from PSARA licence norms for ESM Corporations to function in other States is under discussion with MHA.
- (b) <u>Decision</u>. All States should consider setting up such ESM Corporations which can provide self-sustaining avenue for ESM resettlement and rehabilitation. The issue of easing PSARA licence norms for ESM Corporations to operate in other States be pursued with MHA.
- (c) <u>Action By</u>. State Govts/ UTs, DESW/DGR

19. Item 10 - Empanelment of State Government Hospitals with Ex-Servicemen Contributory Health Scheme (ECHS) to Provide Cashless Treatment.

- (a) <u>Discussions</u>. ECHS has 427 ECHS Polyclinics functioning across 355 districts across the country. However, there are many locations where no ECHS polyclinic or empanelled hospitals/ Military hospitals are available. It was proposed that since Gol has approved empanelled of Govt hospitals/ institutions the State Govt run hospitals could be empanelled for ECHS. IT was brought out by the members that State Govts will also benefit as the Central Govt would be reimbursing the costs of treatment to the State Govts and not the private hospitals. It was expressed by some members that the State Govt hospitals are already having lot of patients and are overcrowded. Putting additional load would not be feasible. It was explained that this need not be done in all State Govt hospitals but only in hospitals at remote locations or in some renowned super speciality State Govt run hospitals where cashless treatment can be done.
- (b) <u>Decision</u>. The proposal for empanelment of State Govt hospitals in remote locations be taken up with the State Govts.
- (c) Action By DESW/ECHS, State Govts/ UTs

20. Item 11 - Institution of Best Performing Rajya Sainik Board Award.

- (a) <u>Discussions</u>. It was proposed to institute a 'Best Performing Rajya Sainik Board' Award to be given during subsequent KSB Meetings. Since the RSBs cater to different sizes of ESM population, there would be criteria set for this. It was also brought out that the intention is to bring out best practices being followed in certain States/UTs and to share these with others.
- (b) <u>Decision</u>. The Issue be examined and modalities may be worked out and taken up on file.
- (c) Action By. KSB Sectt.
- 21. Hon'ble RM concluded the meeting thanking all members for their valuable suggestions. He expressed satisfaction with the active involvement of the States/UT Govts in the endeavour towards ESM Welfare. He remarked that it is a joint responsibility of the Central and State Govt to effectively implement the welfare measures and that we should work together towards transforming their lives. He summarised the following wrt the agenda points: -
 - The concept of Sainik Bandhu meetings needs to be taken forward and considered by all State/UT Govts.
 - (ii) As mentioned by CDS, it is essential that we stress on providing good quality of life to ESM which will also inspire the future generations to join armed forces and look forward to such quality of life.
 - (iii) The best practices of certain States are to be shared with other States. SOPs and advisories as required may be issued by DESW.

- (iv) SPARSH portal is to be leveraged for all aspects of ESM welfare and digital education of ESM community is to be encouraged.
- (v) State/UT Govts should endeavour to fill up vacant posts in RSBs and ZSBs from among ESM.
- (vi) State/UT Govts should to examine the domicile issue and give relaxation to Armed Forces personnel (serving and retired).
- (viii) The land related issues of serving and retired personnel also need to be handled sympathetically. State Govts may issue directives to their DCs/DMs.
- (ix) State/UT Govts should consider reservation for ESM. While most State Govts are already providing this, the mechanism needs to be made better.
- (x) Empanelment of State Govt Hospitals with ECHS may also be taken forward for benefit of ESM in remote areas.
- The Hon'ble RM further expressed that he would undertake a review of these issues within three months along with a few local members of KSB.
- 23. The meeting ended with a vote of thanks by the Secy ESW.
