Subject:-GRANT OF PROVISIONAL PENSION.

Sir,

I am directed to say that the President is pleased to decide that a Service personnel (including a Commissioned Officer) against whom any departmental or judicial proceedings are pending or instituted after retirement in respect of an event which took place not more than 4 years before such institution, may on his retirement on attaining the age of superannuation or otherwise, be authorised a payment of provisional pension not exceeding the maximum pension which would have been admissible to him on the hasis of the qualifying service upto the date of retirement or if he was under suspension on the date of retirement, upto the date immediately preceding the date on which he was placed under suspension.

- 2. The provisional persion may be authorised during the period commencing from the date of retirement to the date on which, upon conclusion of the departmental or judicial proceedings, final orders are passed by the competent authority.
- No gratuity (including death-cum-retirement gratuity) shall be authorised until the conclusion of such proceedings and issue of final orders thereon.
- 4. No commutation of the provisional pension shall be permitted.
- above Shall be adjusted against the final retirement benefits sanctioned to such Service personnel upon conclusion of such proceedings but no recovery shall be made where the pension finally sanctioned is less than the provisional pension or where final pension it reduced or withheld either permanently or for a specified period.
- Nothin contained in this letter shall prejudice the operation of Reddation 3 men final pension and/or gratuity (including death-cum-retir ment gratuity) is sanctioned upon the conclusion of the departmental or judicial processings.
- 7. The competent authority to grant provisional pension under this letter in the case of Commissioned Officers will be the President. In the case of Service personnel below officer rank, the provisional pension may be granted by the COC-in-C.

(of the Command where departmental or judicial proceedings a heing processed, and equivalent authorities on Air Forev and Mavy side in consultation with the Controller of Defence Acc (Pensions).

A show cause notice is not required to be given to individual even if the amount of provisional pension is less than the maximum.

The Pension Regulations will be amended in due coul 9.
